Privacy Policy

Welcome to YOUR CPD SCORECARD (Powered by BLACK ONYX)

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

YOUR CPD SCORECARD is a virtual store based in Cape Town, South Africa and adheres to the requirements of POPI (Protection of Personal Information Act), notwithstanding there is no legal obligation be certified (as of drafting this Privacy Policy).

Copies of our full POPI agreement (typically reserved for corporate clients) may be made available on request, subject to the end users requirements.

YOUR CPD SCORECARD does not actively attract clients for our CPD service from outside of South Africa and therefore is considered exempt from General Data Protection Regulation (GDPR), yet adheres to the same principles that influence POPI, as we may users service providers outside of South Africa.

By accessing this online portal we assume you accept these terms and conditions in full, which include the registration to the BLACK ONYX Monthly Dispatch, in order to retrieve your monthly CPD scorecard. You are most welcome to deregister if you wish.

Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

- Usage Data (to perform the aggregation of CPD points)

Usage Data

We may also collect information how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

Tracking & Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyse our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- We use Session Cookies to operate between various systems to deliver our CPD service.
- We use Preference Cookies to remember your preferences and various settings.
- We use Security Cookies for security purposes.

Transfer of Data

If you are located outside South Africa and choose to provide information to us, please note that we transfer the data, including Personal Data, to South Africa and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

YOUR CPD SCORECARD will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

Disclosure of Data

Legal Requirements

YOUR CPD SCORECARD may disclose your Personal Data in the good faith belief that such action is necessary to:

- To comply with a legal obligation
- To protect and defend the rights or property of YOUR CPD SCORECARD

Security of Data
